6. Membership

(a) Eligibility:

1. Any individual who is a former student of the College at UG, PG, MPhil, PhD or PDC level with a minimum of one academic year study shall be eligible for membership.
2. Those who were dismissed from the college shall not be eligible for membership.
3. Honorary member: The past or present staff of the college (teaching or non-teaching) other than the alumni, shall be eligible for an honorary membership. Honorary members shall not have voting right and they need not pay membership fee.
4. Membership fee is Rupees Two Hundred only (₹ 200/-).
5. A separate register of all members will be kept in the office.


(b) Cessation of Membership:


General body has the power to reject membership to the Association.

7. Management

(a) General Body:

It consists of all members of the Association. The meeting of the General Body shall be Convened as and when required. At least one General Body Meeting shall be convened in the month of January of every calendar year, in which the annual report shall be presented by the Secretary and the audited reports of accounts shall be presented by the Treasurer. A person who is not a member of the association may attend the meeting only with the permission of the President. Only the members of the association, including the executive members, shall have a vote on any motion transacted by the General Body. The person presiding over the function shall have a casting vote in case of a tie.

The General body shall have the following powers and rights.

1. To manage the properties of the association.
2. To make amendments to the bye-laws.
3. To approve the annual report and budget.
4. To elect executive members of the association

(b) Executive Committee:

The annual General Body meeting of the association will be conducted in the month of January of every calendar year and the Executive Committee consisting of a minimum of 21 members will be formed.

1. Executive Committee Office Bearers:



- 14 Members - One member from each PG or UG Department.
(This may be amended when the number of departments increases)

2. The term of the office of the Executive Committee shall be a period of one calendar year.


3. The President by himself or through a letter signed by him may request the Secretary to convene the meeting of the Executive Committee at any time and the Secretary shall oblige such request without fail. Each member of the Executive Committee including the President shall have only one vote. The quorum required for a meeting shall be $\frac{1}{3}$ rd of the members of Executive Committee. The Executive Committee shall prepare and execute detailed plans and programmes for the association to achieve its objectives.

4. Rights, duties and powers of the Executive Committee:


- The President shall normally preside over the meeting of the Executive Committee and the General Body. He shall be primarily responsible for the coordination of activities of the Alumni association.
- In the absence of the President, the senior most Vice President shall preside over the above meetings and conduct the proceedings.
- Secretary will be the Chief Executive of the Association and shall implement the decisions of the Executive Committee. He/She will be responsible for arranging the General Body and Executive Committee meetings in consultation with the Principal and President and shall maintain the minutes.

- The treasurer shall maintain the accounts and present the audited report of income and expenditure in the executive committee. The treasurer and president shall jointly operate all the bank transactions.
- Two Joint Secretaries shall function as the Public Relations Officers and shall work in liaison with Secretary, in all official duties.
- The Executive Committee can prepare amendments to the bye-laws for consideration of the General body.
- The Executive Committee can arrange for proper annual auditing of the accounts of the association and present them before General Body.

(c) Ex – officio chairman:


The Principal (or in charge of the Principal) from time to time, of Government College Kasaragod shall be the Ex – officio chairman of the association. He/She shall be the Ex – officio member of the Executive Committee and General body and shall coordinate the activities of the association with that of the College. He/She may be present in the meeting or may give written permission to conduct the meeting. The Ex-officio chairman shall have the power to give direction to the office bearers to convene meeting of the Association in the emergent situations.


8. Funds of the Association

Funds may be raised through membership fee and donations. The Association can also raise funds through organizing cultural activities, publishing books and souvenirs, arranging training programmes, exhibitions etc. The funds of the Association when collected shall be invested in any of the nationalized banks approved by the executive committee in the joint names of the President, Secretary and the Treasurer and shall be operated jointly by any two. An amount not exceeding ₹1000 / shall be kept by the treasurer as working fund.

9. Annual Report:

The Secretary of the association shall prepare the annual report and the Treasurer of the association shall prepare the audited report for the previous year and get them approved by Executive Committee. The estimated receipts and expenditures of the Association along with the audited report for the previous year and the annual report is to be placed before the annual General Body meeting for its consideration and approval.

10. Stock Register:

The stock register of the association must include the following items.


- Bye-law.
- Register of members.
- Registration Certificate.
- Seals, Minutes Book.
- Accounts books & receipts.
- Letterheads.
- Details of Office furniture
- Details of any other relevant things related to the association.

11. Amendments to the existing Rules & Regulations:

Rules & Regulations in force can be suitably amended and new ones incorporated with the approval of 3/5 th members present in the General Body meetings conducted. The special meeting for amendment is to be conveyed giving 10 days prior notice showing details of amendment by sending the notice through post. The amendment has to be passed with 3 / 5 majority. Thereafter by giving one month time in general body has to be conveyed and in same has to be passed with a majority of 3 / 5 votes in numbers present, within 14 days the amendment is to be filed with District Registrar.

12. Dissolution:

The Association may be dissolved by a decision made to that effect at a meeting of the General body convened for the purpose with a majority of 3/5th members present and voting, the movable and immovable properties of the Association will not be distributed among the members of the Association. If upon dissolution there shall remain, after satisfying payments of all the liabilities of the association any property, movable or immovable, shall be transferred to the Government College or to the Govt. of Kerala, in accordance with the provisions of the Societies Registration Act of 1860. The Association in any way will not indulge in any activities lawfully prohibited by the Government.


