Responses to Queries (DVV) Metric ID - 2.4.2

1. We verified that input given by HEI under this metric does not encompass any visiting or part-time faculty.
2. In metric 2.4.2, we asserted that nearly all faculty members, including guest teachers, possess the necessary qualifications as specified by the UGC.
3. This means that the majority of our teaching staff hold either a NET or PhD qualification.
4. Only a small number of guest faculty members at our HEI were appointed without having a NET or PhD.
5. We are also providing a list of faculty members who have obtained qualifications such as NET, SET, SLET, Ph.D., D.Sc., D.Litt., or L.L.D. over the past five years.
6. We inadvertently overlooked certain teachers who hold NET qualifications, as their highest educational attainment is an M.Phil. We are rectifying the error, and the revised data show an increased total number of faculties with qualifications such as NET, SET, SLET, Ph.D., D.Sc., D.Litt., or L.L.D. for all academic years.
